1) Clinical service mainly in the field of internal medicine at the Veterinary Teaching Hospital including nighttime and holiday clinic.

2) Education, research, and other activities related to clinical veterinary medicine at the Faculty of Veterinary Medicine and School of Veterinary Medicine.

3) Undergraduate courses: Practice in Preclinical Medicine, Practice in Companion Animal Medicine (shared), Practice in Night Times and Emergency Medicine I (shared), Practice in Comprehensive Veterinary Medicine (shared), Seminar in Veterinary Communication (shared), Tutorial Research (shared), Advanced Seminar (shared) and others.

4) Graduate course: Research on Veterinary Science (shared), Advanced Seminar on Veterinary Science (shared), Advanced and Comprehensive Studies on Integrated Specialized Veterinary Clinical Medicine (shared), and others.
